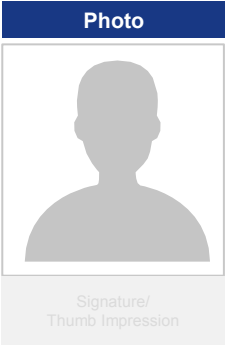

General Instructions:

1. Self-Certification of documents is mandatory.

8. Sole proprietor must make the application in his individual name & capacity.
