Corrigendum to the Notice of 1st Extra-Ordinary General Meeting (EGM) for the financial year 2024-25 of the Shareholders of Systematix Corporate Services Limited to be held on October 14, 2024 at 11:00 am at the Corporate Office of the Company situated at The Capital, A-wing, No. 603–606, 6th Floor, Plot No. C-70, G Block, Bandra Kurla Complex, Bandra (East), Mumbai – 400051, to transact the business matters stated in the Notice of EGM dated September 14, 2024.

Through this Corrigendum it is hereby notified to all the shareholders/members of the Company that in the said Notice of EGM the Resolution No. 1 for Issue of Equity Shares on Preferential Basis to Non-Promoters required following changes in response to instructions from BSE Limited regarding the Company's application for in-principle approval for the preferential issue.

- Pursuant to contravention of Regulation 159 and other applicable provisions of Chapter V of Securities and Exchange Board of India (Issue of Capital and Disclosure Requirements) Regulations, 2018 ("ICDR Regulations"), the name of Mr. Madhukar Chimanlal Sheth, who was subscribing to 2,00,000 Shares in the Preferential Issue now stands replaced with Mr. Pratik Madhukar Sheth in the list of Proposed Allottees(s).

The Executive Committee of the Board, pursuant to the powers delegated to it by the Board of the Company in its meeting held on September 14, 2024 has proposed that the said 2,00,000 Equity Shares which were earlier proposed to be allotted to Mr. Madhukar Chimanlal Sheth shall now be allotted to Mr. Pratik Madhukar Sheth subject to approval of the Shareholders. Accordingly, in the Notice of EGM, Mr. Madhukar Chimanlal Sheth's name will be replaced with that of Mr. Pratik Madhukar Sheth.
