किसी की आपत्ति से अखंड भारत का सपना खत्म नहीं होगा

भोपाल,(निप्र)। मध्य प्रदेश के मुख्यमंत्री डॉ.मोहन यादव ने पाकिस्तान को दो टुक संदेश दिया है। उनके अखंड भारत संबंधी बयान पर आई पाकिस्तान की आपत्ति पर जमकर बरसे। उन्होंने कहा कि किसी की आपत्ति करने से सांस्कृतिक तौर पर अखंड भारत का सपना खत्म नहीं होगा।

अयोध्या में रामलला की प्राण प्रतिष्ठा को लेकर

डॉ. मोहन यादव ने कहा था कि 500 साल के संघर्ष के बाद यह समय आया है। दो हजार साल पहले सम्राट विक्रमादित्य ने अयोध्या में मंदिर बनाया था। आक्रांताओं ने उसे ध्वस्त कर दिया था। हिंदू समाज ने इस बात को लेकर लंबी लड़ाई लड़ी। सुप्रीम कोर्ट ने इस बात की पुष्टि की कि यहां मंदिर था और हिंदओं को इसका हक मिलना चाहिए। उन्होंने एक जगह यह भी

कहा था कि इसे अखंड भारत के पहले कदम के तौर

पर देखा जाना चाहिए।

पाकिस्तान के विदेश मंत्रालय ने टिप्पणी जारी कर कहा है कि भारत में हिंदुत्व विचारधारा का उभार धार्मिक सद्भाव और क्षेत्रीय शांति के लिए खतरा पैदा कर रहा है। भारत के दो प्रमुख राज्यों उत्तर प्रदेश और मध्य प्रदेश के मुख्यमंत्रियों ने ऑन रिकॉर्ड कहा है कि बाबरी मस्जिद का विध्वंस या राम मंदिर की प्राण प्रतिष्ठा पाकिस्तान के हिस्सों पर फिर से कब्जा करने की ओर पहला कदम है। अंतरराष्ट्रीय समुदाय को इस तथाकथित इस्लामोफोबिया हेट स्पीच और हेट क्राइम का संज्ञान लेना चाहिए। संयुक्त राष्ट्र और अन्य संबंधित अंतरराष्ट्रीय संगठनों को भारत में इस्लामिक हेरिटेज साइट्स को कट्टरपंथी समूहों से बचाने में अपनी भूमिका का निर्वहन करना चाहिए। भारत में धार्मिक और सांस्कृतिक अल्पसंख्यकों की सुरक्षा पर बात करना चाहिए। पाकिस्तान ने भारत सरकार से भी मुस्लिमों और उनके पवित्र स्थलों के साथ ही

"As we drove a little further, the tehsildar's car coming from the Umaria side stopped in front of their car near Tala road, Ghaghri village and we stopped our car. Two people got down from both the vehicles with sticks and started beating me and Shivam. They also vandalised Shivam's car and damaged it. Shivam and I suffered a lot of injuries. They also abused them," Dahiya told the police. The police have registered the case against the accused under IPC sections 294, 323, 341 and 34.

The sections under which the case has been filed deal with criminal conspiracy, unlawful assembly, rioting, assault or criminal force to deter public servant from discharging his duty, damaging public property and others. Gandhi said the chief minister directing the DGP to file a case against him shows 'that they have fear in their hearts... They are afraid as the people of Assam are standing up as 'tufan' and 'andhi' (storm) against them'. The barricades were erected along a highway to prevent Congress leaders and supporters taking part in the Yatra from entering the main thoroughfares of Guwahati, the largest city of the northeastern state. As Congress supporters removed the barricades, a scuffle with the police personnel ensued leading to injuries suffered by state Congress president Bhupen Borah and leader of the opposition in the state assembly Debabrata Saikia. Addressing the public from atop a bus, Gandhi said that they have broken barricades but 'we will not break the law'. He alleged that while BJP president J P Nadda was allowed to take the same route earlier, Congress was not permitted. "You should not think we are weak. We have broken the barricades," he told his workers and supporters, calling them 'babbar sher' (lion). The chief minister said that evidence is emerging as to how Gandhi and senior leader Jitendra Singh "instigated the mob to kill Assam police personnel. Our police personnel are servants of the public and do not belong to any royal family. Rest assured, law has a long arm, it will definitely reach you."

Delhi EC buzz...

This sentiment has been reinforced by the fact that some senior party leaders are not averse to changing gears and turning the fervour for Ram into a pre-poll narrative. Curiously, the `confounding note was issued by the Delhi CEO s office on January 19, three days prior to the consecration ceremony. Ostensibly, it focused on compliance/adherence to the timelines given in the Election Planner of Election Commission of India . Marked to the 11 District Election Officers, it stated that the Election Planner is issued by the ECI regarding the timelines/ duration for each activity to start and to be completed. It added that, For the ensuing General Election to the Lok Sabha 2024, the Commission has tentatively given the Poll Day as 16.04.2024 for the purpose of reference and to calculate the start and end dates in the Election Planner . As this led to speculation that the polls may be held earlier than usual, the Delhi CEO s office issued a clarification saying the April 16 date was for reference only. It is clarified that this date was mentioned only for 'reference for officials to plan activities as per Election Planner of ECI, the CEO s office tweeted. Incidentally, in 2019 the Lok Sabha elections had begun on April 11, which was five days earlier than the April 16 reference polling day decided this time. The dates for the last general elections were announced by the Election Commission on March 10 and the polling was over in seven phases from April 16 to May 19. The counting of votes was taken up on May 23.

NASA spacecraft pings Chandrayaan-3 lander on moon

Laser instrument onboard a NASA spacecraft orbiting the Moon has successfully pinged the Vikram lander of India's Chandrayaan-3 mission, the US space agency said.

The laser beam was transmitted and reflected between the Lunar Reconnaissance Orbiter (LRO) and an Oreosized device on Vikram lander, opening the door to a new style of precisely locating targets on the Moon's surface, NASA said.

The lander was 100 kilometers away from LRO, near Manzinus crater in the Moon's south pole region, when LRO transmitted laser pulses toward it on December 12 last year.

After the orbiter registered light that had bounced back from a tiny NASA retroreflector aboard Vikram, NASA scientists knew their technique had finally worked.

Sending laser pulses towards an object and measuring how long it takes the light to bounce back is a commonly used way to track the locations of Earth-orbiting satellites from the

However, using the technique in reverse to send laser pulses from a moving spacecraft to a stationary one to determine its precise location has many applications at the Moon, scien-

"We've showed that we can locate our retroreflector on the surface from the Moon's orbit," said Xiaoli Sun, who led the team at NASA's Goddard Space Flight Center, that developed the retroreflector on Vikram as part of a partnership between NASA and Indian Space Research Organization



"The next step is to improve the technique so that it can become routine for missions that want to use these retroreflectors in the future," Sun said in a NASA statement.

Only 2 inches, or 5 centimeters, wide, NASA's tiny but mighty retroreflector, called a Laser Retroreflector Array, has eight quartz-corner-cube prisms set into a dome-shaped aluminum frame.

The device is simple and durable, scientists say, requiring neither power nor maintenance, and can last for decades. Its configuration allows the retroreflector to reflect light coming in from any direction back to its source, NASA said.

Retroreflectors can be used for many applications in science and exploration and have been in use at the Moon since the Apollo era.

By reflecting light back to Earth, the suitcase-size retroreflectors revealed that the Moon is moving away from our planet at a rate of 3.8 centimeters per year, the US space agency added.

Reacting to the development, ISRO said the Laser Retroreflector Array (LRA) on the Chandrayaan-3 lander has begun serving as a fiducial point (precisely located markers for refer-

"The farmers, youth, teachers, businessmen, lawyers, all sections are sad. The activities of hatred and division of the society are going on in the country and state," he added.

Escalating his attack, Yadav said the BJP "has always ignored" the PDA and is "also conspiring to end reservation".

SC slams Guj cops for flogging Muslim men

Order sentencing policemen to 14-day jail

DELHI: Supreme Court on Tuesday stayed till further orders the decision of the Gujarat High Court sentencing four police officials to a 14-day jail term and imposing a fine of Rs 2,000 each for their involvement in flogging of several men belonging to a particular community.

Hearing an appeal filed by the convicted officials, a Bench presided over by Justice BR Gavai of the apex court extended the stay already put by the High Court on the execution of the sentence. In its October 2023 order, the High Court had convicted the four officials in contempt for breaching the Supreme Court guidelines on arrest as outlined in the

However, it had suspended the execution of the sentence for three months to

allow the convicted police officials to file an appeal. A Division Bench of Justices AS Supehia and Gita Gopi of the HC denounced the act as "inhuman" and a stark violation of human rights. The case stems from an incident on October 3, 2022, where a sizable crowd allegedly disrupted a religious event at Undhela Village of Kheda District. Subsequent to this, videos emerged showcasing police officers publicly flogging several men, an act that drew widespread

condemnation. Five victims, alleging excessive police force and illegal detention, petitioned the Gujarat High Court, referencing a landmark Supreme Court judgment that outlines guidelines for police conduct during ar-
