Union Home Minister Amit Shah defended the NDA's Vice-Presidential candidate, Maharashtra Governor C P Radhakrishnan, stating his selection was "natural" due to India's regional diversity in top government posts. "It was natural that the vice-presidential candidate comes from South India because the President is from East India and the Prime Minister is from the West and North," Shah said.

This reasoning caught the Opposition's interest because Dhankar's continuation in the post would have meant having two people in the top three posts from the West.

Congress general secretary Jairam Ramesh therefore remarked on "X" that, "Today the Home Minister has tried to say

A fresh twist has emerged in the ongoing controversy after saints from Mathura and Vrindavan came out strongly in support of Premanand Maharaj, a day after Jagadguru Ramabhadracharya questioned his spiritual stature.

On Sunday, Ramabhadracharya, Tulsi Peethadheeshwar and a Padma Vibhushan recipient, had said, "If Premanand Maharaj has any miraculous powers, let him speak a single word of Sanskrit in front of me. Let him explain the meaning of any verse that I recite. His popularity is short-lived. He is like a child."

The remarks triggered a wave of criticism from the religious fraternity, with several saints describing them as disrespectful. By Monday, many leading voices from Mathura and Vrindavan had publicly backed Premanand Maharaj, saving the comments were born out of arrogance.

Sadhu Madhusudan Das said, "Ramabhadracharva has grown proud of his knowledge. To make such comments about a divine saint like Premanand Maharaj is condemnable. Devotion is not measured by language. People from across the world come to Vrindavan for bhakti whether they speak Chinese, French or any other tongue."

### **Infiltration** bid across LoC foiled in **Uri: Army**

#### IANS SRINAGAR

Alert soldiers foiled an infiltration bid by terrorists on the line of control (LoC) in the Uri sector of J&amp:K's Baramulla sector on Monday, the Army said. "Troops detected suspicious movement and opened fire," an army official said, adding search operations were being undertaken in the area subsequently.

On August 13, two soldiers were martyred during operational duties in the Uri sector. A spokesman of the Army's Srinagar headquartered Chinar Corps had identified the deceased as Havildar Ankit Kumar and Sepoy Banoth Anil Kumar.

The 740-km long LoC in Jammu and Kashmir remained relatively calm since India and Pakistan reached an agreement on May 10 this year to end four days of intense cross-border attacks and missile strikes, in the wake of the Pahalgam attack on April 22 that left 26 civilians including 25 tourists and a local dead in a terror attack by Pakistanbacked LeT terrorists.


