DRI busts Rs **92crore...**

DRI officers carried out a tactful raid, apprehending two persons, including the chemist, while they were actively engaged in producing the banned substance.

Mephedrone, a synthetic stimulant listed under the Narcotic Drugs and Psychotropic Substances (NDPS) Act, is increasingly popular among youth and is known for effects similar to cocaine and amphetamine, making it a significant threat to public health. Officials also found 541.53 kg of raw materials, including Methylene Dichloride, Ace-Monomethylamine (MMA), Hydrochloric Acid (HCL)and 2-Bromo. A complete set of high-grade processing equipment was also seized. The accused reportedly confessed to manufacturing the drug under instructions from an overseas operator and the Indian kingpin of the cartel. This is the sixth illegal mephedrone

the last one year. Yet another lapse: This latest bust follows a similar lapse last year. In October 2024, a joint operation by the Narcotics Control Bureau and Gujarat ATS unearthed a mephedrone factory worth Rs 1,800 crore at Bagroda industrial complex, also in Bhopal. In both cases, state security agencies and Bhopal police failed to detect the operations, raising concern about their effectiveness in tackling organised drug networks operating in the capital.

3 killed as under...

According to police, the deceased were identified as Gautam Rathore (22), a resident of Dwarkapuri; Rameshwar Panwar (55), a resident of Kundan Nagar; and Rajesh alias Titu Rathore (35), a resident of Tejaji Nagar. The injured has been identified as Sohan (15).

Eyewitnesses said the wall suddenly caved in around 12:30 pm while the workers were engaged in tiling work inside the tank. As the structure collapsed, the workers got trapped beneath the debris, with only their legs and hands visible. It took more than 30 minutes to rescue them due to slush and lack of an escape passage. All three victims succumbed to their injuries before reaching the hospital.

Relatives said Gautam was the son of the contractor at the site. He is survived by his father, a younger brother and two sisters. Rameshwar, who worked as a mason, is survived by his wife and two children. Titu left behind four children.

Experts point to struc**tural flaws-** Experts said the construction site had major structural flaws. The 13-feethigh brick wall was built without basic engineering support such as columns and beams, which ultimately led to the tragedy.

No safety precautions at site- Workers alleged that no safety measures were in place. The walls were weak and built without columns. Mud around the site kept sliding, making the rescue difficult, Ranjit Rathore, a chowkidar said. Another worker, Mahadev Nayak, carried the injured boy to the

hospital in his arms. Another wall collapses after tragedy- Shockingly, another portion of the same wall collapsed two hours after the incident, raising serious concerns about construction quality and safety at the site.

FIR against Cong MLA...

Speaking about the development in court, former BJP MLA Dhruva Narain Singh. Masood's arch rival, said, "The college is based on forged documents. OPPN CONTINUES TO STALL SIR-STRUCK PARL

On Monday, the Opposition renewed its protests in Parliament against the Election Commission's Special Intensive Revision (SIR) of electoral rolls in Bihar. Outside the building, before the day's proceedings, members of the INDIA bloc held a protest, displaying placards that read "Stop Vote Chori (theft)." They also chanted slogans like "vote chor, gaddi chhor" (vote thieves, give up power) and "vote chori band karo" (stop indulging in vote theft).

The Opposition has been regularly protesting the SIR since the start of the Monsoon Session on July 21. Among the kev leaders present were Congress president Mallikarjun Kharge and Samajwadi Party

Kharge posted on X, stating, "The ECI cannot relinquish its constitutional duty and evade genuine queries of political parties. The 'Right to Vote' is the most important right, given to us by the Constitution of India. INDIA will protest any attempt to stifle democracy."

In response to the Election Commission's claim that the Opposition's allegations were baseless, Yadav distributed copies of affidavits to journalists, asserting, "We are sharing copies of paper, affidavits and receipts" concerning complaints about vote deletions. He claimed that the Samajwadi

Nadda accuses Nehru of selling out water security to Pak

In a pointed political attack, Bharatiya Janata Party (BJP) National President and Union Minister Jagat Prakash Nadda has reignited debate over the historic Indus Water Treaty of 1960, branding it one of the "biggest blunders" of India's first Prime Minister, Jawaharlal Nehru.

On his X handle, the BJP senior leader Nadda accused Nehru of compromising India's water security and national interest by unilaterally ceding 80 per cent of the Indus basin waters to Pakistan, leaving India with just 20 per cent. "The nation must know,"

Nadda wrote, "that when Pandit Nehru signed the Indus Waters Treaty with Pakistan, he did so without consulting Parliament. It was placed before the House only two



months later, and that too for a token discussion of just two

He described the move as a "national betraval," asserting that Nehru's decision was driven by personal idealism rather than pragmatic statecraft.

The Indus Waters Treaty, signed on September 19, 1960, in Karachi, was brokered by the World Bank and divided the six rivers of the Indus basin between India and Pak-

India retained control over the eastern rivers-Ravi, Beas, and Sutlej-while Pakistan was granted rights over the western rivers-Indus, Jhelum, and Chenab.

SC dismisses

The Supreme Court on Monday dismissed a petition challenging the validity of the Maharashtra Assembly Elections held in November 2024.

A bench comprising Justice MM Sundresh and Justice NK Singh dismissed a petition filed by Chetan Chandrakant Ahire who sought to declare the election results as void on the allegation that about 75 lakh bogus voters had cast their votes after the closing of the polls at 6 PM.

He approached the Supreme Court challenging the Bombay High Court's dismissal of his writ petition in June 2025. The petitioner also claimed there were several discrepancies in almost 95 constituencies, wherein the number of votes polled and the number of votes counted, did not match.

The High Court bench comprising Justice Girish Kulkarni and Justice Arif Doctor had recorded that the petition was absolutely baseless and had wasted the precious time of the Court.

"The whole day of this Court was wasted while hearing this petition. We were of the view that costs should be imposed on them but we refrain from doing so," the High Court had observed.
