Govt locks 60-day...

As for strategic reserves, the ministry said, "India has 74 days of total reserve capacity and actual stock cover is around 60 days right now, even as the Middle East crisis is in its 27th day."

The government also insisted that "there is no LPG shortage". It said a 40% increase in domestic refinery production has brought daily LPG output to 50 TMT, which is more than 60% of the total daily requirement of around 80 TMT.

With the net daily import requirement now down to 30 TMT, the ministry said 800 TMT of assured inbound LPG cargoes are already secured and en route from the United States, Russia, Australia and other countries.

Due to the availability of LPG, panic has reduced and cylinder demand, which had gone up to 89 lakh cylinders per day, has now come down to 50 lakh cylinders. At the same time, commercial cylinder allocations have increased by 50%.

The ministry cautioned against misleading videos and posts on social media platforms that, it said, selectively use images of queues, global news footage of rationing in other countries, and fabricated claims of impending lockdowns and emergency fuel measures in India to create a false impression of shortage.

India gets safe...

He said ships from the US, Israel and certain Gulf nations playing a role in the current crisis would not be given clearance to transit through the Strait.

"We are in a state of war. The region is a war zone, and there is no reason to allow the ships of our enemies and their allies to pass through. But it remains open to others," he said.

There have been growing global concerns over disruptions in commercial shipping through the Strait of Hormuz, with US President Donald Trump warning Iran of severe consequences if it does not fully reopen the waterway.

MASSIVE INFERNO

The accident occurred between 5:30 am and 6 am near Rayavaram village on the road leading to Podili when the bus rammed into the concrete chip-laden dumper truck, colliding with its fuel tank, which sparked a massive inferno.

Home Minister Vangalapati Anitha said. According to her, the bus belonged to Harikrishna Travels and its owner hails from Kanigiri. She said the bus possessed license and insurance till December 2026.

Chandrababu Naidu expressed grief over the incident.

Markapuram in-charge SP V Harshavardhan Raju said the preliminary probe pointed to the bus veering off into the wrong lane and hitting the truck.

"People sitting in the tipper were injured. The impact was also in the middle of the diesel tank of the tipper. It is visible that the bus hit the truck," Raju told reporters.

'ATIF AHMAD' IN DHURANDHAR 2 SPARKS SP UNEASE

Atiq shadow returns ahead of 2027 battle

The box office success of Dhurandhar: The Revenge has spilled into Uttar Pradesh's political arena, putting the Samajwadi Party on the defensive as the film's character "Atif Ahmad" revives uncomfortable parallels with slain gangster-politician Atiq Ahmed.

Samajwadi Party chief Akhilesh Yadav has publicly dismissed the film as part of a "fabricated narrative", but within political circles the discomfort runs deeper.

Party leaders privately acknowledge that the timing and tone of the portrayal could have implications as Uttar Pradesh moves toward the 2027 Assembly elections. The concern is that repeated visual references linking a figure resembling Atiq to terror networks may harden perceptions among voters.

For Akhilesh Yadav, the challenge is two-fold. On one hand, the SP has worked to move beyond its past image tied to strongmen politics. On the other, the revival of Atiq's persona through popular cinema risks reopening that chapter at a time when electoral positioning is critical.

UNCANNY RESEMBLANCE

The nearly four-hour film, which has clocked a record Rs 236 crore worldwide on its opening day, features the character "Atif" in at least three key sequences. From its opening scene set in Chakia in Prayagraj, the character's attire, mannerisms and rise as a mafia figure mirror Atiq Ahmed closely. While the makers have issued a disclaimer, the resemblance is hard to miss. From the Chakia backdrop in Prayagraj to the depiction of a white-clad strongman with deep criminal networks, the character closely mirrors Atiq's life. What has intensified the political heat is the film's portrayal of "Atif" as having links with Pakistan's ISI and terror outfit Lashkar-e-Taiba.

पीसीपीएनडीटी टीम को मौके पर भेजा गया। टीम ने तत्काल प्रभाव से अस्पताल में स्थापित सोनोग्राफी और सीटी स्कैन मशीनों को सीलबंद कर दिया और पीसीपीएनडीटी प्रमाणपत्र के नवीनीकरण पर रोक लगा दी। कार्रवाई के दौरान प्रशासना भी तैयार किया गया। कलेक्टर शिवम वर्मा ने अपंजीकृत डॉक्टर्स डॉ. सुवश

इंदौर, (न.प्र.)। मध्य प्रदेश उच्च न्यायालय की इंदौर खंडपीठ द्वारा नोटिस जारी किए जाने के बाद पुलिस विभाग ने हड़बड़ी में एक आरक्षक को बहाल कर दिया। मामला उस पुलिसकर्मी का है जिसे एनडीपीएस प्रकरण में नाम आने के आधार पर निलंबित किया गया था, जबकि बाद में न्यायालय द्वारा उसे पूर्णतः दोषमुक्त कर दिया गया। याचिकाकर्ता आरक्षक लखन गुप्ता ने अधिवक्ता यश नगर के माध्यम से याचिका दायर कर बताया कि उसे केवल अपराध क्रमांक 124/2025 में नाम आने के आधार पर 03 मार्च 2025 को निलंबित कर दिया गया था। जांच के दौरान एफएमएस रिपोर्ट में स्पष्ट हुआ कि जब्त पदार्थ में कोई भी मादक पदार्थ नहीं पाया गया, बल्कि केवल पोटेशियम नाइट्रेट मिला। इसके आधार पर विशेष न्यायालय, एनडीपीएस, इंदौर ने 03 फरवरी 2026 को प्रकरण समाप्त कर दिया और सभी आरोपियों को मुक्त कर दिया। इसके बावजूद विभाग ने निलंबन

समाप्त नहीं किया, जिस पर हाईकोर्ट ने सख्त रुख अपनाते हुए पुलिस अधिकारियों से जवाब मांगा कि जब आयाधिक प्रकरण समाप्त हो चुका है तो निलंबन क्यों जारी है। कोर्ट के नोटिस के बाद विभाग ने आनन-फानन में आदेश जारी कर आरक्षक को पुनः सेवा में बहाल कर दिया और निलंबन अवधि को समाप्त कर दिया।

व्या है पूरा मामला

आरक्षक लखन गुप्ता को फरवरी 2025 में दर्ज एनडीपीएस केस में संधिधर रूप से नाम आने पर तुरंत निलंबित कर दिया गया था। बाद में वैज्ञानिक जांच में आरोप पूरी तरह गलत पाए गए और न्यायालय ने प्रकरण समाप्त कर दिया। इसके बावजूद विभाग द्वारा निलंबन जारी रखना मनमाना और गैरकानूनी बताया गया। हाईकोर्ट में याचिका दायर होने पर जैसे ही कोर्ट ने जवाब मांगा, विभाग ने तत्काल बहाली का आदेश जारी कर दिया।
