4.	Details of the violation(s)/contravention(s) committed or alleged to be committed	The Order has been issued to M/s. Systematix Commodities Services Private Limited pursuant to an enquiry regarding alleged violations of regulations by dealing in paired contracts on the National Spot Exchange Limited (NSEL) and after considering the submissions and representations made by M/s. Systematix Commodities Services Private Limited as summarized in the Order. SEBI had issued more than 300 show cause notices to the stock brokers in the NSEL matter and till date has passed orders against more than 140 brokers cancelling / suspending their registration as commodity brokers or disposed of their registrations in cases where the registration of brokers was already surrendered or they were amalgamated. SEBI found these brokers to be not "fit and proper persons," and the issues considered and findings were largely common in the SEBI orders
