# Former UP minister held guilty in gang rape case

LUCKNOW: A special court in Lucknow on Wednesday pronounced former UP minister Gayatri Prajapati guilty in a gang rape case. Two of his associates, Ashok Tiwari and Ashish Shukla, have also been convicted. Judge Pawan Kumar Rai of a special MP/MLA court in Lucknow held Prajapati guilty of gang rape charges in the case under Sections 482/378/407 of the Indian Penal Code. The quantum of punishment will be announced on Friday. In this case, seven people, including Prajapati, were charged.

### Stalin should talk to Vijayan on Mullaperiyar dam: Ramadoss

**CHENNAI:** PMK founder S.Ramadoss on Wednesday said Tamil Nadu Chief Minister MK Stalin should not hold talks with his Kerala counterpart on the Mullaperiyar dam issue. Ramadoss also said Stalin should focus on the issue of strengthening the Mullaperiyar baby dam and increase the water storage level at the Mullaperiyar dam to 152ft from the current 142ft. The PMK leader said Kerala government is hindering Tamil Nadu's efforts in increasing the water storage levels in the dam as luxury cottages and bungalows of popular personalities would go under water.

### Karnataka to fast-track languishing railway projects

**BENGALURU:** Karnataka infrastructure development minister V Somanna on Wednesday said that the state will fast-track railway projects that are languishing since 2007, in a time-bound manner. He said, the cost of most of these projects have almost doubled. "Since 2007, nine railway projects that were launched have not been completed..... after discussion, as the cost has also gone up, putting a burden on both state and central government, we have decided to fast-track these projects. Within 15-20 days, land acquisition and other hurdles will be cleared in a time bound manner," Somanna said.

### Varsity pays tribute to Maulana Azad, launches e-initiatives

**HYDERABAD:** City-based Maulana Azad National Urdu University on Wednesday launched a digital initiative on the eve of National Education Day as a tribute to the first education minister of independent India Maulana Abul Kalam Azad. The digital initiatives, prepared by the Instructional Media Centre, include an exclusive e-content platform in Urdu which is available to students free of cost. Vice-Chancellor of the university prof Syed Anul Hasan, launching the initiative, appreciated the efforts of the media centre in popularising Urdu language through digital media among Urdu and non-Urdu speakers.

### HC seeks govt's stand on Mayookha Johny's plea on FIR

**KOCHI:** The Kerala High Court on Wednesday sought the state government's stand on Olympian Mayookha Johny's plea to quash the FIR against her for allegedly raising false rape allegations. Justice K Haripal directed the Public Prosecutor to take instructions regarding the averments in her plea to quash the FIR and listed the matter for hearing on December 6. The sports person has claimed the case was lodged against her to pressurise her into withdrawing her support to a friend who was raped by a man, who also took her nude photos and used them to blackmail her.

### Stalin alleges corruption by AIADMK in Smart City project

**CHENNAI:** For the second day in succession, Tamil Nadu Chief Minister M.K. Stalin alleged corruption by the AIADMK in the Smart City project which resulted in water-logging in the city. On Wednesday, Stalin hit the water-logged Chennai roads to inspect the damage and relief work. Speaking to the media, Stalin said the earlier (AIADMK) government received "bribes/commission" and had done a haphazard job under the Smart City project and hence the T Nagar area has experienced damage due to water-logging. He said the stagnant water is being pumped out with motors.

### TRS to hold protests against NDA govt for paddy procurement

**HYDERABAD:** Stepping up its attack on BJP and the NDA government at the Centre, the ruling TRS in Telangana on Wednesday said it would organise state-wide protests from next Friday against the Centre's alleged refusal to buy paddy from the state's farmers. TRS Working President K T Rama Rao asked the party leaders to hold dharnas after obtaining permission from District Collectors as the model code of conduct is in force for the MLC elections.

# Chinese army in PoK, surveys villages and military posts

Chinese People Liberation Army personnel are carrying out a survey of the border posts and villages in Pakistan-occupied Kashmir to strengthen the Pakistan military apparatus across Line of Control, said sources, adding Indian security forces are keeping an eye on the activities and motives behind the survey. Source said that around four dozen Chinese People's Liberation Army soldiers arrived in general area Kel, Jura and Leepa sectors of Pakistan-occupied Kashmir a month ago. Indian armed forces say that these areas -- Kel, Jura and Leepa -- are among those from where Pakistan pushes terrorists into Indian territory. Source said that the over 40 People's Liberation Army soldiers came to these regions, divided themselves into groups of five or six each, visited a number of villages and conducted surveys of villages, Pakistan Army posts and "infiltration routes used by terrorists to reach the Kashmir Valley".

The groups were accompanied by Pakistan Army personnel, Inter-Services Intelligence (ISI) officers, and interpreters. Source said that the visit of Chinese troops in Pakistan-occupied Kashmir villages indicates the making of model villages -- which can be used both by civilians and military -- in these regions. "Are Chinese helping Pakistan in building model villages along the Line of Control as they have done across borders with India," questioned a senior government officer over Chinese PLA men visiting these regions. Last week, the US Department of Defense in its annual report to Congress on military and security developments involving the People's Republic of China (PRC) had flagged that China has built a large 100-home civilian village inside disputed territory between the Tibet Autonomous Region and India's Arunachal Pradesh. The report also had stated that these and other infrastructure development efforts along the India-China border have been a source of consternation in the Indian government and media. About the US report, a senior security official, however, stated the said village being referred to has been under Chinese control since 1959. The village has been built by China in an area that was occupied by the People's Liberation Army (PLA) after overrunning an Assam Rifles post in 1959, in an operation known as Longju incident along the frontier in Arunachal Pradesh.

## IAF contingent to take part in Dubai Air Show from Nov 14

An Indian Air Force (IAF) contingent will take part in the Dubai air show to be held at the Al Maktoum International Airport from November 14-18, the force said on Wednesday. The UAE government has invited the Indian Air Force to participate with the Sarang and Suryakiran aerobatics teams. These teams will be performing along with some of the best aerobatics and display teams from across the world, including the Saudi Hawks, Russian Knights and the UAE's Al Fursan. "In addition, the IAF's Light Combat Aircraft (LCA) Tejas will be part of the aerobatics and static displays during the show," the IAF stated. The induction of five Advanced Light Helicopter (ALH) Dhruvs of the Sarang team, 10 BAE Hawk 132s of the Suryakiran team and the three LCA Tejas was completed by November 9, 2021. The induction was supported by the IAF's C-17 Globemaster IIIs and C-130J Super Hercules. On arrival, the contingent was received by Major General Staff Pilot Ishaq Saleh Mohammed al-Balushi of the UAE Armed Forces and other officers of the UAE Air Force.

## 'Communal violence is like lava erupting from volcano' Zakia opposes clean chit to Modi in 2002 riots in SC

Communal violence is like a lava erupting from a volcano which scars the ground it touches, senior advocate Kapil Sibal told the Supreme Court on Wednesday while arguing for Zakia Jafri who has challenged the SIT's clean chit to 64 persons including Narendra Modi, the then Gujarat chief minister during the 2002 riots there. Sibal told a bench headed by Justice A M Khanwilkar that communal violence is a "fertile ground" for future revenge and he too had lost his maternal grandparents in Pakistan. "Communal violence is like lava erupting from a volcano. It is institutionalized violence. Wherever that lava touches, it scars the earth. It is a fertile ground for future revenge," he told the bench, also comprising Justices Dinesh Maheshwari and C T Ravikumar. "I lost my maternal parents to it in Pakistan," a visibly emotional Sibal told the bench, which was hearing Jafri's plea. The senior advocate, who was representing Jafri, said he is not accusing A or B but a message must be sent to the world that this is "unacceptable" and "cannot be tolerated". He said this is a "historic matter" because the choice is between ensuring that rule of law will prevail or letting people run amok. "The argument in the matter is going on in the apex court. Jafri is the wife of slain Congress leader Ehsan Jafri, who was killed at Gulberg society in Ahmedabad on February 28, 2002 during the violence.



## 4 workers killed as roof of coal mine caves in

Four workers died after a roof in a coal mine project at the State-owned Singareni Collieries Company Ltd (SCCL) collapsed on them in Mancheril district of Telangana on Wednesday. The incident occurred at Srirampur area while roof-stitching was on, the SCCL and the police said. A portion of the roof fell on the four workers, in the age group of 32 and 60, burying them under the rubble and resulting in their death, they said. Chairman and managing director of SCCL N Sridhar conveyed his condolences to the bereaved families. Also, he ordered an enquiry into the incident and directed the officials concerned to submit a report. "It should be seen that such incidents do not recur," he said. The top official, in a press release, announced employment to one eligible member of the family of each of the deceased besides an ex-gratia between Rs 70 lakh and Rs one crore.

## BJP LEADER EXPELLED FROM PARTY AFTER SPEAKING AGAINST LoP

In yet another incident of infighting between the saffron camp, BJP Howrah district president Surojit Saha expelled from BJP after he spoke against the Leader of Opposition Suwendu Adhikari. No sooner did Saha comment against the Leader of Opposition, than the West Bengal BJP chief Sukanta Majumdar expelled Saha from the party. Notably, Suwendu at a closed door meeting claimed that several BJP workers of Howrah are in tandem with TMC leaders for which the BJP couldn't do well in Howrah in the recently concluded Assembly polls. Countering the Leader of Opposition's claim, BJP district president Saha claimed that Suwendu is in close proximity with the TMC leaders. "Suwendu claimed that I am close to TMC leader Arup Roy but he should have proof to suffice his claims. So far the saffron camp has always praised me now just by what the defected leader had said had expelled me. I didn't get any official communication and no one has reciprocated any information to me," said Saha.

## BJP leader and ex-deputy CM asked to demolish illegally built house

The Jammu Development Authority (JDA) has served a notice on senior BJP leader and former deputy chief minister Nirmal Singh asking him to demolish his illegally constructed house on the outskirts of the city within five days. Singh and his family moved into the palatial bungalow near the Army's ammunition sub-depot at Ban village of Nagrota on July 23 last year, even though the high court had in May 2018 directed the authorities to ensure "strict implementation" of a 2015 notification barring general public from carrying out any construction within 1,000 yards of defence works. "The matter is sub-judice and I will be consulting my lawyers for future course of action," the BJP leader told PTI, confirming the receipt of the notice issued by the JDA on November 8.

## Bitcoin scam will cost Bommai his job, claims Congress leader

Congress leader Priyank Kharge on Wednesday claimed that the 'bitcoin scam' will cost Chief Minister Basavaraj Bommai his job and the BJP government will see a third CM this time too, as witnessed in 2008-13. "This government is trying to shut the bitcoin scam very systematically. BJP senior leaders, their children and officials are involved in it.... It is a multi-crore scam, drugs case kickback, transfer kickback has been obtained through bitcoin. Investment scams have also happened through it," the MLA alleged. "The Bitcoin case will cost the Chief Minister his chair. The previous tenure of the BJP government saw three Chief Ministers. This time also you will see three Chief Ministers," he told reporters in the district headquarters town of Kalaburagi. The BJP's tenure between 2008-13 saw B S Yediyurappa, D V Sadanada Gowda and Jagadish Shettar as Chief Ministers, while Bommai succeeded Yediyurappa in July this year. Demanding that the government make public documents about it and hand over the bitcoin case to the Enforcement Directorate or CBI, the former Minister sought to know what was the cause of the delay.
