Tamil Nadu Chief Minister MK Stalin on Thursday expressed serious concern over the United States' roll

Earlier this month, Stalin had written to Prime Minister Narendra Modi, warning of the detrimental effects of the US tariffs on Tamil Nadu's export-oriented sectors, particularly textiles

out of its decision to hike tariffs on textile imports to 50%. He said the move has significantly impacted the state's exports, especially from Tiruppur district, a leading textile hub.

Taking to social media, Stalin said, "The #USTariff hike to 50% has hit Tamil Nadu's exports hard, especially #Tiruppur's textile hub, causing a trade impact of nearly Rs 3,000 crore and putting thousands of jobs at risk. I reiterate my demands the Es 3,000 crore trade impact on Tamil Nadu's textile sector due to the tariff increase, underscoring the severity of the situation.

Earlier this month, Stalin had written to Prime Minister Narendra Modi, warning of the detrimental effects of the US tariffs on Tamil Nadu's export-oriented sectors, particularly textiles.

Removal of duty on US cotton a fatal blow to farmers: Kejriwal

NEW DELHI

Aam Aadmi Party (AAP) national convenor and former Delhi Chief Minister Arvind Kejriwal on Thursday accused the Centre of betraying farmers by removing the 11 per cent import duty on cotton, alleging that the move was taken under pressure from the US.

Kejriwal said the decision would render domestic farmers uncompetitive, as US cotton would now be available Rs 15-20 cheaper per kg than Indian cotton.

He claimed that India's textile industry will procure cheaper imports before October, leaving Indian farmers without buyers when their produce reaches the market.

"Farmers have invested heavily in cotton by taking loans. This decision of the Modi government will render their hard work meaningless".

'India must impose higher tariffs on US imports'

New Delhi: Arvind Kejriwal on Thursday demanded that India impose higher tariffs on US imports and asserted that the whole country will support this decision.

Addressing a press conference, Kejriwal alleged that the BJP-led Central government has decided to waive off 11 per cent duty on cotton imported from the US, which could impact the business of local farmers here. There was no immediate reaction from the Central government. Stating that Prime Minister Narendra Modi's decision could prove detrimental to India's farmers, the AAP chief demanded that the government impose higher tariffs on US imports.

I asked one television anchor, when this judgment was uploaded, within minutes you started analysing the judgment. How could you read a 1,000-page judgment within 10 minutes?" he recalled, contrasting it with the more careful practice of earlier generations of court reporters.

The discussion was moderated by Newslaundry's Managing Editor Manisha Pande, with Justice Muralidhar and Professor Gopal Guru as co-panellists. Picking up on Justice Oka's point, Justice Muralidhar acknowledged the performative aspect of modernday courtrooms. "This is an inevitable situation. Courts are theatres of performance. Lawvers and sometimes judges are aware of it and they are performing for the gallery," he observed.

He cautioned, however, that the circulation of viral courtroom clips, from sharp judicial observations to moments of rebuke, risked skewing public perception. "It is inevitable in a democratic space, but the media must resist over-sensationalising and place them in context," he said.

The discussion began with Pande asking whether India had done enough to protect press freedom and shield individuals from "trials by media."

Justice Muralidhar was unequivocal in his response: "That's a no-brainer, because we've not done enough."

in a gas cylinder explosion at home, officials said on Thursday, citing statements of doctors and nurses of the private hospi-**DOWRY MURDER**

tal where she was first admitted. According to a memo from the hospital where Bhati was taken to on

August 21, she had "suffered severe burns in a gas cylinder explosion at home" and was brought there in a critical condition by a cousin of her husband, Vipin Bhati. "The statement of the doc-

tors and nurses who were present at the time of her admission has been recorded.

Nikki told them that she sustained burn injuries due to a blast in a gas cylinder," a police official said.

The police said that they are probing all aspects of the case and collecting statements before

taking further action. An inflammable liauid

recovered from Nikki's room has been sent for forensic analysis.

Investigators are also examining several video clips circulating in the public domain in connection with the incident.

The new details emerge amid earlier allegations that Nikki was set on fire by her husband and in-laws over dowry demands.
