NASA's deep space atomic clock completes mission
WASHINGTON: NASA's Deep Space Atomic Clock, which has, since two years, pushed the timekeeping frontiers in space, has successfully ended its mission. The mission ended on September 18, the US space agency said in a

statement this week. Built by NASA's Jet Propulsion Laboratory in southern California, the Deep Space Atomic Clock is an ultra-precise, mercury-ion atomic clock encased in a small box that measures about 25 centimetres

on each side – roughly the size of a toaster. The instrument was hosted on General Atomics' Orbital Test Bed spacecraft and was launched aboard the Department of Defense Space Test Programme 2 mission on June 25, 2019. —IANS



Sense of purpose is associated with better memory

A new study, led by Florida State University researchers, has shown a link between an individual's sense of purpose and their ability to recall vivid details. The findings of the study were published in the journal 'Memory'. The researchers found that while both a sense of purpose and cognitive function made memories easier to recall, only a sense of purpose bestowed the benefits of vividness and coherence. The study focused on memories related to the COVID-19 pandemic. "Personal memories serve really important functions in everyday life," said Angelina Sutin, a professor in the College of Medicine and the paper's lead author. Nearly 800 study participants reported on their sense of purpose and completed tasks that measured their cognitive processing speed in January and February 2020, before the ongoing coronavirus pandemic took hold in the US. Researchers then measured participants' ability to retrieve and describe personal memories about the pandemic in July 2020, several months into the public health crisis. Participants with a stronger sense of purpose in life reported that their memories were more accessible, coherent and vivid than participants with less purpose. —ANI

Over 1 in 2 Indian professionals facing work stress: Report

More than one in two Indian professionals are currently feeling stressed at work as well-being measures have become a luxury for many in the last 18 months, adversely affecting mental health of working professionals in the country, a LinkedIn report showed on Thursday. When asked to share their primary reasons for work stress, employed professionals cited 'balancing work with personal needs' (34 per cent), 'not making enough money' (32 per cent), and 'slow career advancement' (25 per cent) as the top three stressors at work today. Amid such stressful times, one in three professionals are also seen drawing optimism from the availability of



jobs (36 per cent) and improved control over expenses (30 per cent) in today's recovering, yet competitive, jobs marketplace.

"While nearly half of (47 per cent) employed professionals wish to end work at reasonable hours, only about one-third (36 per cent) were actually able to do so. And while 41 per cent planned for time-off, only 30 per cent could take time off in the past two months," LinkedIn's India Country Manager Ashutosh Gupta said. As workforce priorities

continue to change in these transformative times, the findings go on to indicate that flexibility and work-life balance will serve as critical talent drivers across the Indian professional landscape for years to come. While greater flexibility remains a mutual need across generations, younger professionals found it easier to take a break than their older cohorts. The findings, based on a survey response of 3,881 professionals from July 31 to September 24, revealed that millennials were 2x more likely to take time-offs, while Gen Z professionals were 1.5x more likely to take breaks during the day, when compared to Baby Boomers. —IANS

Pros, cons of common weight-loss surgeries

A research team, led by the University of Michigan Health, has found that of the most common weight-loss surgeries, sleeve gastrectomy is safer than gastric bypass.

The findings of the study were published in the journal 'JAMA Surgery'. Five years after each procedure, patients who'd undergone a

sleeve gastrectomy, which involves removing part of the stomach, had a lower risk of death and complications than those who had chosen to have their stomachs divided into pouches through gastric bypass surgery.

However, gastric bypass was superior in one area: Sleeve gastrectomy patients were more likely to need follow-up surgery, which could

indicate that gastric bypass is more effective long-term, even though it carries more risks.

"It's really important for patients to understand the risk of significant issues like death, complications, and hospitalisation after these two procedures because that helps inform the

decision about which type of bariatric surgery to choose," said Ryan Howard, MD, a general surgery resident at Michigan Medicine and the first author of the study. "You could envision a scenario where a patient is averse to that risk, and so even if a sleeve gastrectomy doesn't confer as much

weight loss, they may want it because it's the safer surgery," Howard added.

"On the other hand, if a patient has a lot of comorbidities, and a bypass is going to afford a better clinical benefit, maybe that risk is worth it," Howard concluded. —ANI
