Samsung to use recycled material in new mobile products by 2025

SEOUL: Samsung Electronics said on Thursday it will use recycled material in all of its new mobile products by 2025 as the South Korean tech giant vowed to minimise environmental impact. Samsung unveiled its new sustainable vision for the mobile business, "Galaxy for the Planet," at its Unpacked event on Wednesday, where the company also introduced new foldable smartphones. To achieve its initial sustainability goals, Samsung said

it will first try to incorporate recycled material in all new mobile products and eliminate all plastics in mobile packaging by 2025. The world's largest smartphone vendor also plans to achieve zero power standby consumption of smartphone chargers, aiming for a reduction to below 0.005 watts by 2025. So far, the company has reduced the standby power consumption across all of its smartphone chargers to 0.02 W, reports Yonhap news agency.

JBN gets ready for its 'Mahakumbh'



64% rise in ransomware attacks in last one year

There has been a 64 per cent increase in ransomware attacks between August 2020 and July 2021, revealed a report on Thursday. Barracuda, a cloud-enabled security solutions provider, in its latest Threat Spotlight, analysed 121 ransomware incidents between August 2020 and July 2021.

They found many attacks are being led by a handful of high-profile ransomware gangs. Ransomware gang Revil accounted for 19 per cent of the attacks while new ransomware strain DarkSide caused 8 per cent of the attacks. "Ransomware criminals have refined

their tactics to create a double extortion scheme. The initial steps towards safeguarding an organisation from any possible ransomware attack involve assuming vulnerability and setting a goal of not paying the ransom," said Murali Urs, Country Manager, Barracuda Networks India, in a statement.

It is also "necessary to implement anti-phishing capabilities in email and other collaboration tools, and consistently train your users for email security awareness," and "crucial to stay put with a secure data protection solution that can identify your critical data assets and implement disaster and recovery capabilities", Urs said.

Ransomware criminals are penetrating the foundation of the digital economy across the globe, from trusted software vendors to IT service providers. Attacks on corporations, such as infrastructure, travel, financial services, and other businesses, made up 57 per cent of all ransomware attacks between August 2020 and July 2021, up from just 18 per cent in Barracuda Network's 2020 study.

Infrastructure-related businesses account for 10 per cent of all the attacks. In fact, ransomware attacks are quickly evolving to software supply chain attacks, which reach more businesses in a single attempt.

Gen Z is willing to rent clothes to reduce wastage, finds study

The findings of a new study by Washington State University researchers suggest that Gen Z adults are interested in using apparel rental services to reduce overconsumption. Apparel rental, also known as collaborative apparel consumption, extends the life of an article of clothing because people don't throw it away after wearing it a few times. The findings were published in the journal Sustainability. "The idea is growing more

popular, especially among Gen Z consumers," said Ting Chi, the corresponding author on the paper and chair of WSU's Department of Apparel, Merchandising, Design, and Textiles. "They are very interested in sustainable consumerism, care about the environment, and are willing to make changes to help the planet."

Chi and co-authors Lindsay McCoy and Yuan-Ting Wang surveyed 362 adults born between 1997 and 2002 from across the United States. They found that the respondents were still interested in being



fashionable, but don't need to own a product.

"They're more focused on usage," Chi said. "That increases a product's lifecycle if it is worn by different people. It also reduces waste while still meeting consumer needs for variety."

The study identified several factors that made clothing rental acceptable to Gen Z adults. The most important, according to Chi, is the perceived effectiveness of making a difference. If consumers feel their effort will have an impact, they're more likely to accept a change. Another factor was the focus on usage, not ownership. "They would get newer products more frequently than if they own an item," Chi said. "The desire to get more new articles of clothing made it more likely that they would try rental services."
